This study will be examined using the disability inquiry perspective lens; the focus will be on former offenders and their lived experience within the labor market. Through the process of phenomenological reflection and interviews, former offenders will share their stories and memories of social and economic exclusion as a result of their criminal record and the experience after a clean record.

An interview with study participants will be conducted to describe the experiences of find employment with a criminal record and finding employment after having their criminal record sealed

Potential risk to participants includes transitory feelings of guilt, stress, embarrassment and lost of self-esteem. These feelings may arise during the interview process from thinking or talking about attitudes and behavior related to criminal expierences. Risks will be minimized by following ethical research procedures and informing and ensuing participants understand what the study entails. Before the interview beginning, participants will be informed that they have the option to not answer any question that makes them feel uncomfortable or end the interview at anytime. The researcher will also be able to provide participants with a list of services that can assist with managing emotional risk.

Thank you for taking the time to offer your knowledge and experiences with this study. The purpose of this study is to examine the lived experience of finding employment with a criminal record and then finding paid work once a criminal record was scaled. This study is a means of gathering data as part of the dissertation process for Niogara University Ooctor of Philosophy in Leadership and Policy As criminal record scaling is a new law in New York State, the findings from this research will benefit lawmakers and the overall criminal justice system to better understand this unchartered territory.

At any time during the interview process if participant feel uncomfortable in anyway, they have the right to not answer any question or end the interview all together. Participant's contribution to this study is voluntary and participants will not be compensated. By signing this consent participants understand their right to withdraw and discontinue participation from this study at any time without penalty
